Conditions

1. Persons under 18 years of age:

12-16 years old only accepted if accompanied by parent or guardian

16-18 years old only accepted unaccompanied if the Booking Form has been signed by parent or guardian, stating this fact after the signature.

2. Medical Fitness:

An adequate level of fitness is required bearing in mind the physical activity involved in sailing. If you have any doubts about your ability to participate you should check with your doctor before booking. Should you suffer from any condition, particularly those noted in the Booking Form you must disclose them to us. It does not necessarily mean that a medical condition will disqualify you from taking part.

3. Payment:

A deposit of £75.00 is required if the booking is more than 30 days from the start of your holiday. The balance is payable in full 30 days prior to the commencement date.

If booking within 30 days of commencement the fee is payable in full.

If these terms are not observed *Sail-Elixir* reserves the right to resell the dates.

No booking will be confirmed without receipt of the booking form and the appropriate payment.

Payment by cheque or draft should be made to N G & S V Bown.

The cost does not include: alcoholic beverages, marina fees or meals taken ashore.

4. Cancellations:

Any deposit is not returnable in the event of cancellation.

If cancellation is made within 30 days of commencement of your holiday we will make every effort to fill your place but you will remain liable for the full amount. If we are able to find a replacement we will refund the fee less the deposit.

If *Sail-Elixir* is not able to provide a confirmed holiday a full refund will be made and any liability will immediately cease. It is strongly recommended that Holiday insurance is taken out to cover the possibility of cancellation.

5. Insurance:

Sail-Elixir its servants, agents or employees accept no liability in respect of personal injury, loss or damage of effects howsoever caused whilst participating in a sailing holiday. The appropriate insurance is recommended to cover cancellation, medical expenses, personal accident, loss or damage to personal effects etc.
